7. Town Manager's Update (5 min)

Background:

These are your "payables" for the last two weeks that pertain to the vendors and employees that are paid by the Town. Accounts Payable Warrant 25 is high due to roadwork payments of \$147,171.81. Payroll Warrants 24 & 22 is high due to outside details and traffic grant hours (Town is reimbursed for these hours).

10. Unfinished Business: (50 min)

a. Consideration and discussion of Land Use Ordinance.

Background:

The Land Use Committee met on September 10th and voted to change the minimum lot size in the rural areas to one acre, and have the minimum road frontage at 150 feet. This corresponds to the change in the comprehensive plan voted on in June. The Board some time ago agreed to move the Land Use Ordinance to a vote as soon as this change to the proposed ordinance was authorized. If the board wants this to be voted on in

the November election then they must make this decision now and authorize the language of the question on the ballot.

Recommendation:

The recommendation is the Select Board should make a motion to bring the Land Use Ordinance to a vote in the November election.

b. Consideration and discussion of citizens' initiative and impacts on services.

Background:

The Citizens' Initiative passed to the Board on September 14, 2015 states as follows: Shall the Town of Paris be required to receive the approval of 50% of its registered voters before any expenditures of the municipality can result in the mil rate exceeding the state average as determined by the Maine Revenue Service Tax Division starting with the July 2016 budget.", has been validated by the Town Clerk. I sent the language to the Town Attorney for legal review. His opinion is the question asked in the petition is an ultra vires request; this means it is beyond the power of the voters to do what is being asked in the petition. I have attached the explanation of this legal term and the email from the Town Attorney further detailing the opinion. The Select Board has two options: one to reject the petition based on the attorney's opinion; or two, to move the petition to vote placing an advisory message under stating that this is a recommendation or advisory opinion only. I asked the department heads to look at their budgets and inform the Board what each department would look like under Selectmen Hodgkins scenario (Admin Budget -200,000 less, PD Budget -300,000 less, Highway Budget -150,000 less, FD Budget -150,000 less, and Capital Budget -347,000 less). Each department head will be ready on Monday to discuss how this type of cut will affect services to the residents. Prepare yourself... these cuts are drastic and the service reductions are equally as drastic.

For example: The 44% cut to the Administration Budget results in the office only open for 20 hours per week. Reduction of one Deputy Clerk, office will be open 2 ten hour days consecutively; the Town would no longer register motor vehicles; Clerks would take excise tax only and then residents will have to go to a DMV Branch or online to register vehicles. The office would no longer sell hunting/fishing licenses, or register snowmobiles, ATVs or boats. All staff would be reduced in hours including the CEO, Bookkeeper, and Town Manager.

Recommendation:

No recommendation at this time.

c. Consideration and discussion of approving the language for the November ballot.

Background:

The Select Board by law must authorize the language on the ballot, specifically the wording about passing ordinances. I have provided a copy of the language regarding the Land Use Ordinance, should the Board choose to move the ordinance to a vote.

The recommendation is for the Select Board to make a motion to approve the language of the November ballot.

Background:

The Town received three poverty abatement applications. One of the applications does not meet the precedent set by the Town many years ago of having liened tax years ready for foreclosure.
